

# Rules and Eligibility

## **Applicant Eligibility**

Applicant must be a U.S. Citizen or Permanent Legal Resident of the United States. Applicant must be enrolled full-time at an accredited college or university between January 2020 and January 2021.

Applicants must also have a cumulative grade point average of at least 2.5 on a 4-point scale.
